## RIGHT TO A PERMIT



## A Who is eligible to apply for a permit?

- Unemployed South African citizens
- Holder of a valid permit or refugee status documents
- Do not hold an existing trading permit for another site
- Does not employ more than 10 persons
- Does not have an interest in more than 1 entity or partnership which conducts informal trading

The municipality can consider the following in granting sites:

- Race
- Gender
- Disability
- Whether you are a first time informal trader or a dependant of an existing informal trader
- The goods you intend to sell
- Whether you were previously convicted of an offence for informal trading
- Tax payer status

## D Right of traders in permit applications

- Right to access information on all processes and procedures on permits applications
- proof of receipt for submitted permit application
- Right to a signed copy of trading agreement, regulations and rules for permit holders
- Right to a decision or application outcome within a reasonable period
- Right to appeal decision in cases of unsuccessful permit applications
- Right to reasons
- Right to a fair and transparent allocation process

## B Application Process

- Vacant sites must be advertised in local newspapers & municipality website
- Permit applications are submitted to the Business Support Unit (BSU) for assessments
- Apply using the BSU standard form (this is available at their offices)
- Four documents to be submitted; proof of residence, application letter; confirmatory affidavit on unemployment status, letter from the area Councilor
- Apply to the health department for compliance certificate if you plan on selling food and perishables

## E Suspension of trading permits

- The municipality may only suspend your permit if you;
- breach any conditions of your permit, bylaws or any other laws
  - you are convicted of trading in illegal goods or providing an illegal service
  - you receive reasonable notice to that effect
  - you are now employed in the formal sector

## C Permit Form (section 12)

A permit will contain;

- A specified trading area marked by a number
- Trading conditions e.g minimum and maximum trading hours
- Types of goods and services allowed to be traded
- Expiry date for the permit
- Requirements for trading structures in your area
- Specify number of assistants
